Makar, P.E., M.S, who is BNC, Product Control Unit Supervisor with Miami-Dade County Department of Permitting, confirmed the following items on October 21, 2011 about the Soyko Industries prefabricated adjustable metal roof frame, QuickFrames, designed for the support of roof-mounted equipment and skylights:

1. A Notice of Acceptance (NOA) is an optional requirement
2. The products use requires no testing
3. A Certificate of Competency is not required
4. Structural calculations will be required by a FL licensed and registered Structural Engineer for permitting.

Caruso Turley Scott Structural Engineers, Inc. is licensed in all 50 states, and we meet the requirements of Miami-Dade County to have a Florida license and registration, which will satisfy the Miami-Dade County requirement.

For Quick Frame projects located in Florida:

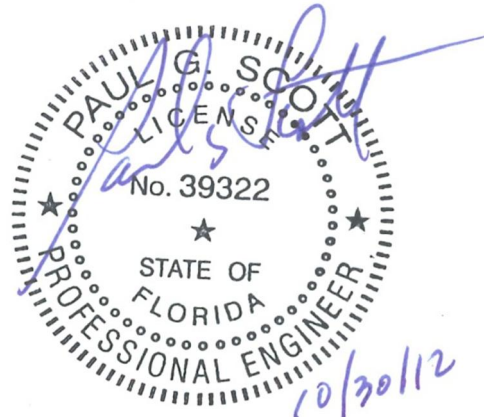
1. The contractor, building engineer, or owner shall provide data on the building structure and for the equipment that will be located on the frame using the attached site specific data sheet.
2. CTS will provide sealed site specific QuickFrame calculations and a sealed site specific QuickFrame 'S1' sheet (per attached sample) for submittal to the required jurisdiction.
3. The capacity of the building structure is the responsibility of the building owner. CTS can also provide that service under separate contract.
